Mr. Corey David Plummer was born on February 10, 1971 in Michigan (U.S.A.). He graduated from Michigan State University in 1996 with a degree in Political Science and Economics, earned a Master of Business Administration from Arizona State University in 1999 and received an Executive Finance Certificate from INSEAD in 2016. During his time at Centerbridge Partners he helped build the firm's European PE investment team, improved the performance of two legacy portfolio companies (one of which was monetized), sourced, helped review and drove the execution of new investment opportunities and led the successful investment in Senvion, the German wind turbine manufacturer and service provider. Mr. Stefan Kowski currently serves on the Supervisory Boards of TLG IMMOBILIEN AG (from 2018), and on the Management Boards of Odyssey Europe AS (from 2018), Odyssey Europe Holdco S.à r.l. STEPHEN MARK PEEL

Mr. Stephen Mark Peel was born on December 29, 1965 in Blackburn (United Kingdom). He received his BA/MA from Downing College, Cambridge in 1987 and received a Master of Advanced Study from the Jackson Institute of Global Affairs at Yale University in 2015. Since 2016, he has been a Visiting Fellow at Oxford University's Blavatnik School of Government.

At the forefront of international private equity industry for over 25 years, Mr. Peel was at Goldman Sachs from 1989 until 1997, before joining TPG Capital. During his 17 year tenure as a partner at TPG, he was part of leadership group that took the firm from fewer than 20 professionals with some \$3 billion of assets under management based only in US to one of largest PE firms in world with over 350 professionals managing some \$60 billion of assets across North America, Europe and Asia.

Mr Peel started and co-led TPG in Europe, pioneered new markets in emerging Europe, opened the firm's Russian office, and from 2009 to 2014 headed the Asian business, creating several of the partnership's most profitable investments.

In 2014 Stephen founded SMP Policy Innovation Limited, a not-for-profit policy organisation, where, until 2017, he focused his efforts on public policy and philanthropic initiatives. He also co-founded the philanthropic Private Equity Foundation (now Impetus PEF). He is on the boards of several non-profit organisations including Global Witness and the Open Contracting Partnership.

Mr Peel is currently one of the founding partners at Novalpina Capital (founded in 2017) and serves on the Supervisory Boards of Odyssey Europe AS (from 2018) and on the Management Boards of Novalpina Capital Partners I LuxCo S.à r.l. (from 2017) and Novalpina Capital Group S.à r.l. (from 2017).
